**Please be aware of the following Totteridge Policies:**

**Cancelations and Timing:** Persons booking an event are responsible for keeping the course informed about any changes in counts or details of booked events. **Totteridge requires a final count one (1) week in advance of the event.** Event Contact is responsible for the number of players booked. Full payment is due on the day of the event.

**Golf Cart Liability:** Persons operating golf carts are responsible for damages sustained before, during, or after a round. Upon request, Contact person shall provide communication detail for contacting individual players in the group.

**Adherence to Totteridge Pace of Play Policy:** Through USGA Pace of Play resources, it was determined that a foursome is able to play an 18-hole round at Totteridge in 4 hours and 10 minutes or less. With a 10-minute tee-interval and mandatory carts, adhering to a pace of play shall be the responsibility of every group.

**All beverages shall be purchased thru Totteridge:** Obtaining and maintaining Food and Liquor Licenses is an initial and ongoing expense and liability of Totteridge. Therefore, ALL beverages consumed on the property must be purchased therein. A variety of beers, wines and liquors and non-alcoholic beverages are available for purchase.

**Limitations on alcohol taken on the course:** For the good of all, and for the purpose of maintaining a smooth operation to be enjoyed by all, Totteridge may limit the quantity of alcohol beverages purchased for consumption on the golf course. On or off the course, Totteridge reserves the right to refuse sales to individuals who appear intoxicated.
